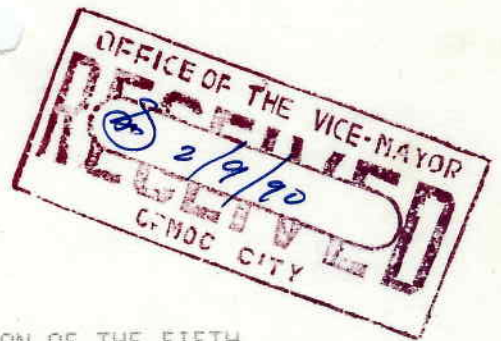

RESOLUTION NO. 14

A RESOLUTION EXPRESSING OUR PROFUSED APPRECIATION AND HEARTFELT THANKS TO THE GOOD PEOPLE OF KAOHSIUNG CITY, REPUBLIC OF CHINA, THROUGH THEIR EQUALLY GOOD AND HONORABLE MAYOR SU NAN-CHENG, FOR THEIR GENEROUS DONATIONS OF ONE (1) UNIT SEDAN, ONE (1) UNIT STATION WAGON - FORD, ONE (1) UNIT AMBULANCE (VAN TYPE) AND TWO (2) UNITS BUSES TO THE CITY GOVERNMENT OF ORMOC.

WHEREAS, in one fine morning of January 11, 1990 at the Honorable Placido C. Enecio Session Hall of the Sangguniang Panlungsod building, Ormoc City, Her Honor, the City Mayor, has officially informed the Honorable Members of the Sangguniang Panlungsod ng Ormoc, in SESSION, (in her keynote address delivered during her most significant STATE OF THE CITY ADDRESS before a mammoth crowd of city councilmen, barrio officials and other invited guests and visitors), among others, the laudable donations from the good people and respectable Mayor of Kaohsiung, Republic of China, of the following vehicles to the City Government of Ormoc, namely: one (1) unit Sedan, one (1) unit Station Wagon - Ford, one (1) unit Ambulance (Van type) and two (2) units Buses; however, one of said two buses is still left at the place of origin for possible exchange to a Dump Truck, the latter item being much needed especially for barrio or barangay roads and services;

WHEREAS, currently, the aforesaid donated vehicles have already arrived in Ormoc City, except for one (1) unit Bus as above reasoned out;

WHEREAS, this august Body has reckoned out that the aforementioned donations are living testimonies that somewhere many miles distance across the seas, in far away place of Kaohsiung, Republic of China, there can still be singled out a generously great and good people with equally good and respectable Mayor who deserve the sincerest praise and gratitude and for whose generosity is worthy of emulation;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, so unanimously considers the good Samaritan manifestations of the good people and the Honorable City Mayor of Kaohsiung, Republic of China, very magnanimous and as one course towards having their donated vehicles redound to services for the interest of the constituents of Ormoc City;


