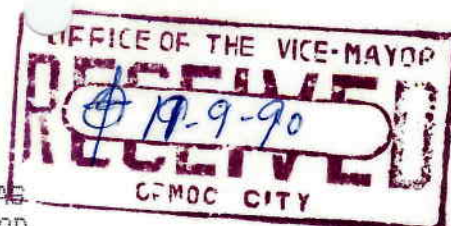

A RESOLUTION APPROVING RESOLUTION NO. 1 S. 1990 OF THE  
REORGANIZATION COMMITTEE RE UPGRADING THREE (3) POSITIONS AND  
CREATING TWENTY ONE (21) ESSENTIAL POSITIONS IN THE LOCAL PLANTILLA  
OF PERSONNEL OF ORMOC CITY FOR CALENDAR YEAR 1991.
