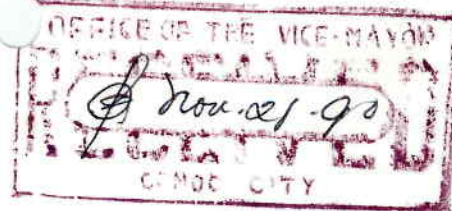

RESOLUTION NO. 144

A RESOLUTION ADDRESSED THE STATION COMMANDER, ORMOC-INP, REQUESTING HIM TO STOP THE ILLEGAL "HANTAK" ACTIVITY NOW ONGOING AT THE MARKET AREA NEAR A POLICE OUTPOST.

WHEREAS, this august Body has passed Resolution No. 110 s. 1990, requesting the Station Commander of Ormoc-INP to conduct routinary inspections on illegal gamblings, (Illegal Cockfightings, "Hantak", etcetera), and/or stop these illegal gambling activities in Ormoc City;

WHEREAS, said resolution has emphasized the pernicious effects of these vices to society, particularly on the decadence of the people's behavior and morale, for usually the victims of these vicious forms of gambling would wittingly succumb to the commission of crimes X X X for the reason of generating funds;

WHEREAS, notwithstanding the passage of said resolution, illegal "Hantak" activity has still continued its operation, one clear particular example of it can be found at the public market near a police outpost wherein its public exposure and closeness to an outpost of law enforcers has aggravated to a situation much revolting to the mind and conscience of all law abiding citizens of the community;

NOW, THEREFORE, on motion of Kagawad Eufrocino C. Codilla, Jr., duly seconded by Kagawad Jose B. Conejos; be it


