RESOLUTION NO. 145

A RESOLUTION RETURNING TO THE ORMOC NORTH AND THE ORMOC SOUTH DISTRICTS IRRIGATORS ASSOCIATIONS THEIR RESOLUTION NO. 4 S. 1990 WITH THE OBSERVATION THAT SAID RESOLUTION CANNOT BE ACTED FAVORABLY BY THIS AUGUST BODY CONSIDERING THAT THE ACTS COMPLAINED OF ARE WELL WITHIN THE PROVISIONS OF THE NATIONAL LAW, P.D. NO. 1067.

PRESENTED for consideration is Resolution No. 4 s. 1990 of the Ormoc North and the Ormoc South Districts Irrigators Associations requesting the Honorable Sangguniang Panlungsod ng Ormoc to enact a City Ordinance providing penalties regarding destructions of irrigation facilities, (through enumerated acts as alleged therein), and on violations of Irrigation Laws, so rampant in Bao River Irrigation System;

WHEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Antero T. Fiel; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to return to the Ormoc North and the Ormoc South Districts Irrigators Association their Resolution No. 4 s. 1990 with the observation that said resolution cannot be acted favorably by this august Body considering that the acts complained of are well within the provisions of the National Law, P.D. No. 1067;
