A RESOLUTION EARNESTLY REQUESTING THE MANAGEMENT OF AEROLIFT
TRANSPORT CORPORATION TO SERVICE ORMOC-CEBU ROUTE SO AS TO SERVE
THE COMMUTING PUBLIC CONVENIENTLY AND IN COMFORT.

WHEREAS, it is a fact that Ormoc City is a focal point of entry and
departure of commuters and the hub of distribution of consumers and
service goods due to its central and strategic location in Leyte
province and with the existence of the Philippine-Japan Highway;

WHEREAS, although the principal medium of travel from Ormoc to Cebu
and vice versa is by sea, nevertheless, many of the daily commuters in
Ormoc City are often stranded in said place, for these commuters, many
of them from far flung municipalities and provinces, could no longer be
accommodated by the very inadequate services of shipping companies;

WHEREAS, in a way to attend to and meet itineraries of business
travels on time, a good number of the commuters have confided their
resolve to be accommodated by air services, however, servicing of the
Philippine Airlines for Ormoc-Cebu is just limited to one flight and
only in alternating days within every week, - a situation whereby not
all or even a substantial portion of the commuters can readily avail of
the services;
