**RESOLUTION NO. 153**

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EFFECT AN INTER-FUND TRANSFER IN THE AMOUNT OF \$180,000.00 FROM THE SURPLUS OF THE GENERAL FUND TO INFRASTRUCTURE FUND TO COMPLETE THE INFRASTRUCTURE REQUIREMENT OF \$180,000.00 FOR THE YEAR-END-BENEFITS AND CASH GIFTS OF CASUAL EMPLOYEES UNDER THE INFRASTRUCTURE FUND.

WHEREAS, due to financial constraints of the Infrastructure Fund at this point in time, necessitating, therefore, movement of funds from the surplus of the General Fund to Infrastructure Fund to complete the Infrastructure Fund requirement of P220,000.00 for the year-end-benefits and cash gifts of casual workers of the city government under the Infrastructure Fund;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Gregorio A. Vrastorza, Jr. and Celso P. Porcadilla; be it

**RESOLVED**, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer to effect an Inter-Fund transfer in the amount of P180,000.00 from the surplus of the General Fund to Infrastructure Fund to complete the Infrastructure requirement of P220,000.00 for the Year-End-Benefits and Cash Gifts of the casual employees under the Infrastructure Fund;
