WHEREAS, Ormoc City was one of the places in Western and Eastern Visayas mercilessly hit by super-typhoon "Ruping" on November 12 and 13, 1990;

WHEREAS, the said typhoon has wrought enormous damages to properties and injury to lives, with so many houses being blown down rendering more than a thousand families homeless;

WHEREAS, the sad aftermath of this unmitigated fury of nature has made MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC decided in making this APPEAL for HELP, for attention and consideration, for brotherhood and for sympathy to the plight of the helpless and unfortunate victims of the said catastrophe;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., UNANIMOUSLY SECONDED by all the mga Kagawad present; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE QUEZON CITY GOVERNMENT THROUGH ITS HONORABLE CITY MAYOR FOR FINANCIAL ASSISTANCE TO THE TYPHOON VICTIMS IN ORMOC CITY;
