

RESOLUTION NO. 16

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE TOTAL AMOUNT OF P240,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), A) P210,000.00 OF WHICH TO BE MADE AVAILABLE AS THE CITY'S COUNTERPART FUNDING OF 50% OF THE TOTAL REQUESTED WITHDRAWAL OF P420,000.00 FROM THE SPECIAL DEVELOPMENT ACCOUNT, AND, B) P30,000.00 TO BE UTILIZED AS AID TO THE PEACE AND ORDER COUNCIL FOR OPERATION AGAINST INSURGENCY OF ITS SPECIAL OPERATIONS TEAM (SOT) IN SEVERAL BARANGAYS OF ORMOC CITY.

WHEREAS, per Resolution No. 09, current series, this august Body has authorized the Honorable City Mayor of Ormoc to withdraw funds amounting to P420,000.00 from the Special Development Account (SDA) on deposit with the Office of the Provincial Development Assistance Project, Department of Local Government, for the purchase of one (1) unit "Backhoe" equipment for barangay road maintenance and development purposes;

WHEREAS, Par. No. 3 of Memorandum Circular No. 88-55 dated October 17, 1988 of the Honorable Secretary, DLG, Manila, provides that: " X X X city governments are likewise enjoined to earmark fifty percent (50%) of their respective SDA balances to support or finance the development and implementation of new projects which they have determined to be feasible and relevant to their needs";

WHEREAS, Resolution No. 15 s. 1990, embodying Appropriation Ordinance No. 90-06 (Paragraph A), has appropriated an amount of P210,000.00 representing the city's counterpart funding of 50% of the total requested withdrawal of SDA fund - P420,000.00, for the purchase of one (1) unit "Backhoe" equipment, from out of the 20% Economic Development Fund (EDF) subject, however, to the authority granted for this purpose by the Department of Local Government;

WHEREAS, ON THE OTHER HAND, the Peace & Order Council - Ormoc City, has requested appropriation amounting to P30,000.00 to help finance for at least another month of operation its Special Operations Team (SOT) against insurgency in several barangays in Ormoc City;

WHEREAS, Resolution No. 15, current series, embodying Appropriation

(RES. NO. 16)

Ordinance No. 90-06 (Paragraph B thereof), has appropriated an amount of P30,000.00 to be made available as Aid to the Peace & Order Council, Ormoc City, to be sourced from the 20% Economic Development Fund, subject, however, to authorization granted by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Vice Chairman, Committee on Finance, duly seconded by Kagawad Sixto T. Pongos (relative P210,000.00); mga Kagawad Eufrocino C. Codilla, Jr. and Rodolfo L. Rivilla, Jr., (pertaining to P30,000.00); be it

RESOLVED, to pass a resolution earnestly requesting the Department of Local Government through Regional Director Resurreccion S. Salvatierra, DLG, Region VIII, Tacloban City, to authorize the Honorable City Mayor of Ormoc City to utilize the total amount of P240,000.00 from out of the 20% Economic Development Fund (EDF) of the General Fund for the following purposes:

- a) P210,000.00 - to be made available as the City's counterpart funding of 50% of the total requested withdrawal of SDA fund - P420,000.00, for the purchase of one (1) unit BACKHOE equipment for barangay road maintenance and development, and
- b) P30,000.00 - to be utilized as Aid to the Peace & Order Council relative operation against insurgency of its Special Operations Team (SOT) in several barangays of Ormoc City;


ENACTED, February 15, 1990.

Locsin, City Mayor, Ormoc City; the City Treasurer, the City Budget Officer, and the DLG Office, -all in Ormoc City; and, a special copy to Honorable Luis T. Santos, Secretary, Department of Local Government, Manila;

CARRIED UNANIMOUSLY, (pertaining to P210,000.00);

CARRIED. Ten (10) affirmative votes, two (2) abstentions, registered by mga Kagawad Arnulfo C. Salazar and Jose B. Conejos, (pertaining to P30,000.00 aid to the Peace & Order Council).


