RESOLUTION NO. 160

A RESOLUTION APPROVING THE SUGGESTED FARE RATES PRESENTED BY THE TRICYCLE DRIVERS AND OPERATORS ASSOCIATIONS IN AN EMERGENCY MEETING WITH THE COMMITTEE ON TRANSPORTATION AND COMMUNICATION OF THE SANGGUNIANG PANLUNGSOD NG ORMOC ON DECEMBER 6, 1990, PENDING APPROVAL OF AUTHORIZED RATES BY LTFRB.

CONSIDERING the increase of gasoline and other motor fuels brought about by the developing crisis in the Middle East and other related contributing factors, the Members of the Committee on Transportation and Communication of the Sangguniang Panlungsod has met and convoked into an Emergency Meeting on December 6, 1990 at SP Session Hall, this city, Tricycle Drivers and Operators for whatsoever bargaining both sides may arrive at relative to tricycle transportation fare rates.

NOW THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., Chairman, Committee on Transportation and Communication, severally seconded by mga Kagawad, Benjamin F. Tugonon, Sixto T. Pongos and Nelson DL. Geneston; be it.
