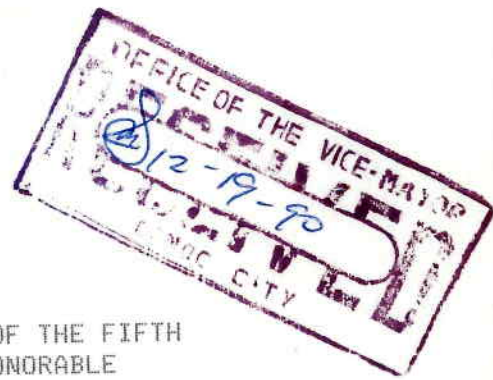

RESOLUTION NO. 161

A RESOLUTION APPROVING RESOLUTION NO. 8 S. 1990 EMBODYING ORDINANCE
NO. 2 OF THE BARANGAY COUNCIL OF MAS-IN, ENTITLED "AN ORDINANCE
PROHIBITING ASTRAY ANIMALS IN BARANGAY MAS-IN, PROVIDING PENALTIES
FOR VIOLATION THEREOF."

WHEREAS, this august Body is in receipt of Resolution No. 8 s. 1990
adopting Ordinance No. 2 of the Barangay Council of Mas-in, entitled,
"An Ordinance Prohibiting Astray Animals in Barangays Mas-in, Providing
Penalties for Violation Thereof";

WHEREAS, said resolution has alleged the following:

a) That the barangay constituents are in need to
undertake cleanliness and beautification of their barangay
which is felt need by majority of the residents.

b) That this resolution when finally realized will give
their barangay the following benefits:

1. Good sanitation to the residents
2. Ornamental plants will beautify the whole barangay
3. Plants and tress are sources of food supply, and
4. The implemental of this project could only be made
possible through the assistance of the residents
of said barangay

WHEREAS, Ordinance No. 2, as embodied in aforesaid resolution has
further alleged the following:

"SECTION 1. No person shall allow any astray animals to
roam around the area of Barangay Mas-in to avoid eyesore to
the public, very unsanitary to look at, and to possibly
cause destructions to plants in everybody's area;

(RES. NO. 161, S. 1990)

"SECTION 2. Any person who violate this Ordinance shall be punished by a fine of P50.00 (fifty pesos) for each carabao or cow, P30.00 (thirty pesos) for each pig or goat."

WHEREAS, this august Body conforms to the embodiment of said resolution-ordinance because it is well within the powers and prerogatives of the Barangay Council as expressly provided in the Local Government Code, otherwise known as Batas Pambansa Blg. 337;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Arnulfo C. Salazar; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to approve Resolution No. 8 s. 1990 embodying Ordinance No. 2 of the Barangay Council of Mas-in, entitled, "An Ordinance Prohibiting Astray Animals in Barangay Mas-in, Providing Penalties for Violation Thereof";

ENACTED, December 13, 1990.

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor, the City Treasurer, the ABC President, the DLG - ACGO Officer and the Honorable Punong Barangay, Barangay Mas-in, - all in Ormoc City;
