RESOLUTION NO. 162

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AN IN BEHALF OF THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) RELATIVE THE CREATION OF A COMMUNITY EMPLOYMENT CENTER (CEC) IN ORMOC CITY.

WHEREAS, DLG Memorandum Circular No. 90-21 dated 21 March 1990 has "directed all X X X City Nayors X X X to organize a Community Employment Center (CEC) in their respective local government units", in pursuance to the objective of the Department of Labor and Employment (DOLE), "to bring the employment service assistance down to the community level to ensure greater outreach in the delivery of employment services";

WHEREAS, among others, the aforestated Memo-Circular has further expressly provided the following:

- a) To operationalize the CEC concept, the DOLE shall provide technical assistance for the establishment and maintenance of the CEC and the local government unit shall be responsible for its administrative and financial requirements.
- b) In line with the economy measure being implemented by the government and to allow the local government unit to the DOLE-sponsored project without additional financial burden, the CEC functions should be assigned to an appropriate existing office in the local government unit concerned.

WHEREAS, Her Honor, the City Mayor, in her 1st Indorsement dated 4 December 1990, has endorsed to the Honorable Sangguniang Panlungsod for appropriate action the said request of DOLE for the organization of a Community Employment Center in Ormoc City, with the draft forms of the subject Memorandum of Agreement and the Appointment to be issued to the Community Employment Coordinator to handle the Community Employment

Center and, with the recommendation that the function of the Community Employment Center be handled in CONCURRENT CAPACITIES by existing staff of the City Government;

WHEREAS, through the representation of the Honorable Chairman, SP Committee on Industrial Labor, Center Chief Luisito Manago of Ormoc City Technological Manpower Training and Research Center, has been recommended as the Community Employment Coordinator of the said Center in CONCURRENT CAPACITY, subject, however, to the approval of the Honorable City Mayor for the reason that the Power of Appointment is an inherent function lodged in the Office of the Local Chief Executives

WHEREAS, this august Body shares the view of the national government that unemployment and underemployment are some of the serious problems of our country today, which must be given priority concern by Administrators;

NOW, THEREFORE, on motion of Kagawad Nelson DL. Geneston, Chairman, Committee on Industrial Labor, duly seconded by Kagawad Celso P. Adolfo; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) RELATIVE THE CREATION OF A COMMUNITY EMPLOYMENT CENTER (CEC) IN ORMOC CITY;

ENACTED, December 13, 1990.
