RESOLUTION NO. 164

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF P3,190.88 FOR SALARY DIFFERENTIAL OF FORMER FIREMAN TIMOTEO F. APARIS UNDER RA 602 (MINIMUM WAGE LAW) AGAINST THE AVAILABLE BALANCES OF TWO (2) PREVIOUS APPROPRIATIONS, SPECIFICALLY, APPROPRIATION ORDINANCES NOS. 90-37 AND 90-49, BOTH SERIES 1990, AS APPROVED BY THE SANGGUNIANG PANLUNGSOD.

WHEREAS, this august Body is in receipt of a Voucher with supporting papers attached, issued in favor of Mr. T. F. Aparis, former Fireman of Ormoc City Fire Station for payment of his salary differential under RA 602 (Minimum Wage Law) covering the period from July 17, 1953 to October 15, 1961;

WHEREAS, the City Budget Officer has recommended that authority be granted the City Treasurer to charge the subject claim of P3,190.88 against available balances of two (2) previous appropriations, specifically Appropriation Ordinances Nos. 90-37 and 90-49, all Series 1990 which were approved by this august Body to cover claims of similar nature;

WHEREAS, this august Body has found out the foregoing claim to be in proper order, the same being supported with Service Record, Appointment papers, and 4th Indorsement dated March 22, 1989 from the COA Chairman, Quezon City;
