

## RESOLUTION NO. 170

A RESOLUTION MOST PROFOUNDLY THANKING HONORABLE VICENTE T. PATERNO, CONGRESS OF THE PHILIPPINES, MANILA, FOR HIS DONATION OF P50,000.00 THROUGH PMB CHEQUE NO. 824684 FOR THE VICTIMS OF TYPHOON "RUPING" IN ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter dated 7 December 1990 from Honorable Senator Vicente T. Paterno, Congress of the Philippines, Manila, addressed Her Honor, the City Mayor of Ormoc, said letter having informed about the Honorable Senator's donation of Fifty Thousand Pesos (P50,000.00) through Senate cheque, PMB No. 824684 for use by the city in its relief and rehabilitation work for the victims of super typhoon Ruping

WHEREAS, Her Honor, the City Mayor, has acknowledged receipt of said donation through a letter to Honorable Senator V. T. Paterno dated 12 December 1990 and, having received the said amount in behalf of the City Government under the following conditions: a) that the amount shall be used exclusively for relief and rehabilitation program to ameliorate the damage caused in the city by typhoon Ruping, b) that the City Mayor shall cause the City Treasurer within a week from date to issue Official Receipt for the amount and send it to the Senate of the Philippines, and c) that the City Mayor's Office will submit to the Senate a Report of Disbursements and Status of Funds out of this amount on or before February 28, 1991;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD  $_{\rm NS}$  ORMOC, in SESSION, has considered the donation of the Honorable Senator of the distinguished Philippine Senate in Congress as an emulative example of magnanimity and public-spiritedness, so laudable and much commendable, hence, must be accorded with due course and immediate action;
