A RESOLUTION EARNESTLY REQUESTING ENGR. RAMON A. ALEJO, REGIONAL EQUIPMENT ENGINEER, REGION VIII, TACLOBAN CITY, TO RELEASE AT LEAST 1,000 UNSERVICEABLE TIRES TO BE USED IN THE CONSTRUCTION OF ARTIFICIAL REEF MODULES TO ALL COASTAL BARANGAYS IN ORMOC CITY.

WHEREAS, this august Body is in receipt of a communication from the Municipal Agricultural Officer, Department of Agriculture, Ormoc City, addressed through Her Honor, the City Mayor, which letter is reproduced hereunder, thus:

The office of the Department of Agriculture, Ormoc City has its on-going program under the Fishery sector which is the Artificial Reef Project.

Much to our desire to establish this said project to all coastal barangays within the city, but the problem lies in the supply of materials such as used tires.

In this connection, we would like to solicit the benevolent assistance of the City Sangguniang Panlungsod, by way of making a resolution address to Engr. Ramon A. Alejo, Area Equipment Engineer, Region 8, Tacloban City, requesting at least one thousand (1,000) unserviceable tires as one of our materials on the construction of artificial reef modules.


