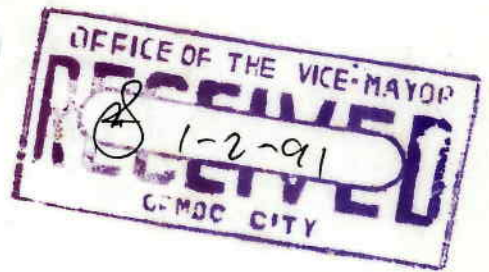

RESOLUTION NO. 172

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE OVER LOT NO. 2243-E WITH MRS. JACINTA ESNERO BALL, OWNER OF SAID LOT CONTAINING AN AREA OF 1,322 SQUARE METERS SITUATED AT BARANGAY PUNTA, THIS CITY, AT P150.00 PER SQUARE METER, SAID LAND BEING TRAVERSED BY THE CONSTRUCTION OF APITONG STREET EXTENSION GOING TO RUBI VILLAGE OF THE CITY'S ROAD-RIGHT-OF-WAY PROGRAM, AND, PURSUANT TO RESOLUTION NO. 158 S. 1990 EMBODYING APPROPRIATION ORDINANCE NO. 90-53.

WHEREAS, this august Body has enacted Resolution No. 158 s. 1990 adopting Appropriation Ordinance No. 90-53 which has authorized the 1st Installment payment of P50,000.00 to Mrs. Jacinta Esmero Ball relative her road-right-of-way claim over her land Lot No. 2243-E with an area of 1,322 square meters at Barangay Punta, Ormoc City, which has been traversed by the construction of Apitong Street Extension going to Rubi Village at P150.00/square meter, an approved rate per Resolution No. 6-90 of the City Appraisal Committee;

WHEREAS, official documents evidencing absolute transfer of ownership of the subject premises are indispensable for records file in government office/s concerned;

NOW, THEREFORE, on motion Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, duly seconded by Kagawad Rodolfo L. Rivilla, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to sign, for and in behalf of the City Government, a Deed of Absolute Sale over Lot No. 2243-E with Mrs. Jacinta Esmero Ball, owner of said lot containing an area of 1,322 square meters situated at Barangay Punta, Ormoc City, at P150.00/square meter, as approved by the City Appraisal Committee, and, in pursuance with Resolution No. 158 s. 1990 embodying Appropriation Ordinance No. 90-53;


