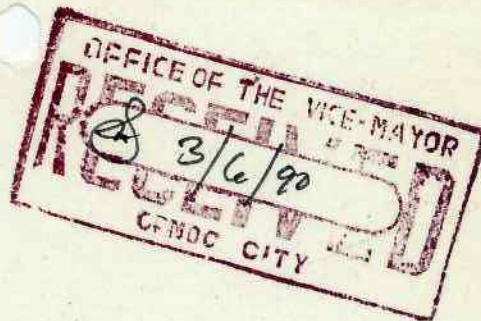

RESOLUTION NO. 21

A RESOLUTION ADDRESSED THE HONORABLE CHAIRMAN, HOUSING AND URBAN
DEVELOPMENT COORDINATING COUNCIL, MANILA, THROUGH ITS TACLOBAN
REGIONAL OFFICE, REQUESTING THE TECHNICAL ASSISTANCE OF ENGR.
GLICERIO C. MIRAMBEL, JR. HOUSING AND LAND USE REGULATORY BOARD,
HUDCC, REGION VIII, TACLOBAN CITY, FOR ORMOC CITY'S SLUM
IMPROVEMENT PROGRAM IN ITS BARANGAY, DON FELIPE LARRAZABAL.

WHEREAS, this august Body is in receipt of a letter dated February
20, 1990 from the Housing and Land Use Regulatory Board, Housing and
Urban Development Coordinating Council, Region VIII, Tacloban City, re
response to a letter of the Honorable Chairman, Committee on Urban
Development, Sangguniang Panlungsod, Ormoc City, requesting for the
technical assistance of Engr. Glicerio C. Mirambel, Jr. of said Regional
Office relative Ormoc City's Slum Improvement Program at Barangay Don
Felipe Larrazabal, Ormoc City;

WHEREAS, in said letter-response, Ms. R. D. Sombise, Officer-In-
Charge, Housing and Land Use Regulatory Board, HUDCC, Tacloban City,
has advised this representation that before the Staff of said Regulatory
Board can be officially involved in the Slum Improvement Program &
Project at Barangay Don Felipe Larrazabal, Ormoc City, a clearance must
be first secured from its Central Office through a resolution, among
others, to be submitted forthwith to HUDCC Regional Office, Tacloban;

WHEREAS, Barangay Don Felipe Larrazabal in Ormoc City is a heavily
populated barangay in which housing and other living conditions therein
are generally impoverished or poor;

WHEREAS, as articulated to by the Officials of said barangay that
due to so many squatters in said area, one could no longer breathe an air
of serenity, neither could sleep at nights with any sense of security;

WHEREAS, the sad condition of said place has positively motivated attention and consideration among the City Officials to look for viable plans that may provide said barangay and its constituents a BETTER QUALITY OF LIFE;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Urban Development, jointly seconded by mga Kagawad Sixto T. Pongos, Benjamin F. Tugonon and Celso P. Porcadilla; be it

RESOLVED, to pass a resolution addressed the Honorable Chairman, Housing and Urban Development Coordinating Council, Manila, through its Regional Office, REQUESTING THE TECHNICAL ASSISTANCE OF ENGR. GLICERIO C. MIRAMBEL, JR., HOUSING AND LAND USE REGULATORY BOARD, HUDCC, REGION VIII, TACLOBAN CITY, FOR ORmoc CITY'S SLUM IMPROVEMENT PROGRAM IN ITS BARANGAY, DON FELIPE LARRAZABAL;

RESOLVED, FURTHER, that a special copy of this request be sent to the Honorable Chairman, Housing and Urban Development Coordinating Council, Allied Bank Bldg., Ayala Avenue, Makati, Metro Manila;

RESOLVED, FURTHERMORE; to furnish copies of this resolution one each to Ms. Rufina D. Sombise, Officer-In-Charge, Housing and Land Use Regulatory Board, HUDCC, Region VIII, Tacloban City; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; and, Engr. Ruben C. Penserga, City Engineer, Ormoc City;
