RESOLUTION NO. 23

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE WITH ENGR. J. A. LAURENTE, LOT OWNER OF A PARCEL OF LAND UTILIZED BY THE CITY'S ROAD-RIGHT-OF-WAY, COVERED BY TCT NO. 23597, CONTAINING AN AREA OF 500 SQUARE METERS, SITUATED AT BRGY. DONA FELIZA VILLAGE, ORMOC CITY, PURSUANT TO RESOLUTION NO. 22 EMBODYING APPROPRIATION ORDINANCE NO. 90-11 ENACTED MARCH 1, 1990.

WHEREAS, this August Body has enacted Resolution No. 22 embodying Appropriation Ordinance No. 90-11 authorizing payment in an amount of P60,000.00 to Engr. Jovencio A. Laurente, lot owner of Lot No. 5229-A-6 of subdivision plan Pst. 08-004915, covered by TCT No. 23597, containing an area of 500 square meters, situated at Dona Feliza Mejia Village, Ormoc City;
