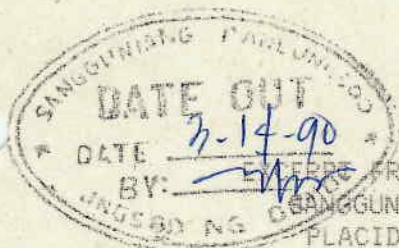
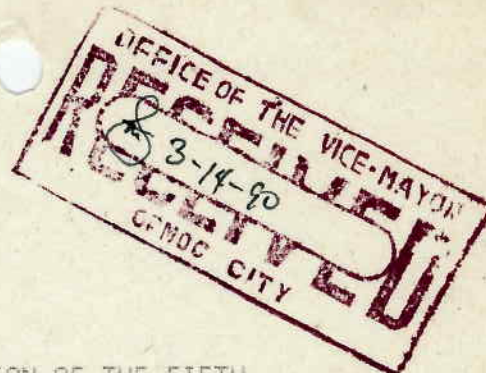

A RESOLUTION FAVORABLY ENDORSING AND ADOPTING IN TOTO HOUSE BILL NO. 25346, ENTITLED, "AN ACT PROVIDING FOR THE SYSTEMATIC DEVELOPMENT OF SECONDARY CITIES AND PROGRESSIVE TOWNS INTO A NETWORK OF URBAN CENTERS FUNCTIONING AS THE FOCAL CENTERS OF COUNTRYSIDE RURAL ECONOMIC DEVELOPMENT."

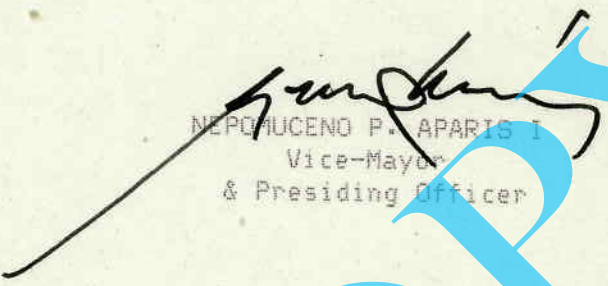
