

RESOLUTION NO. 29

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT WITH THE FAR EAST CORPORATION (WINNING BIDDER), FOR THE PREPARATION OF THE DESIGN, PLANS AND SPECIFICATIONS AS WELL AS FOR CONSTRUCTION SUPERVISION SERVICES OF THE PROPOSED MULTI-PURPOSE GYMNASIUM AT GOVERNMENT CENTER SITE, ORMOC CITY.

WHEREAS, a letter dated March 6, 1990 from the Honorable Acting City Mayor Nepomuceno P. Aparis I, vice Her Honor, the City Mayor, the latter being Out-of-Town on official business, said letter being addressed the Honorable Sangguniang Panlungsod through the Honorable Chairman, Committee on Infrastructure, requesting for passage of a resolution authorizing the Honorable City Mayor to sign, for and in behalf of the City Government, a contract for the preparation and design of the plans and specifications and for construction supervision services of a proposed Multi-Purpose Gymnasium;

WHEREAS, the Prequalification, Bids and Awards Committee (PBAC) in its meeting on February 8, 1990 had passed a resolution awarding the aforesaid contract, as FIRST PARTY thereto, being the winning bidder, to the Far East Corporation lawfully engaged in the architectural, engineering and planning business;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Infrastructure, jointly seconded by mga Kagawad Arnulfo C. Salazar and Nelson L. Geneston; be it

RESOLVED, to authorize the Honorable City Mayor to sign, for and in behalf of the City Government, a contract with the Far East Corporation for the preparation of the design, plans and specifications as well as


for construction supervision services of the proposed Multi-Purpose Gymnasium to be constructed at Government Center, Cogon, Ormoc City;
