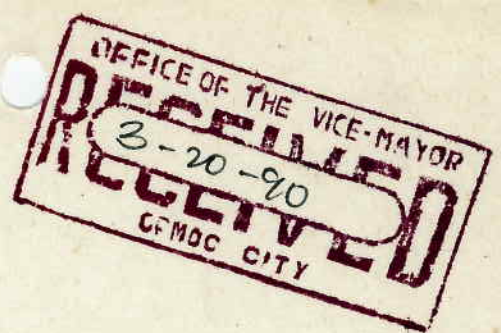

RESOLUTION NO. 31

A RESOLUTION APPROVING RESOLUTION NO. 12-90 OF THE SANGGUNIANG
BARANGAY OF IPIL, ORMOC CITY, RE SHARING OF THE COLLECTION OF P5.00
TOLL FEE TO BE COLLECTED PER HEAVY TRUCK OR HEAVY EQUIPMENT PASSING
THROUGH THE BARANGAY STREET OF BRGY. IPIL, SIXTY PERCENT (60%)
THEREOF TO BE SET ASIDE FOR THE IMPROVEMENT OF THE STREET AND FORTY
PERCENT (40%) FOR THE BARANGAY TANOD BRIGADE AS THEIR ALLOWANCES.

WHEREAS, Ordinance No. 2-89 of the Barangay Council of Ipil, this
City, re Toll Fee collection of P5.00 to be imposed for every Heavy
Truck or Heavy Equipment that passed by the Barangay Street of Brgy.
Ipil, has been approved by the Sangguniang Panlungsod ng Ormoc per
Approved Minutes (90-20) of its Regular Session on February 1, 1990;

WHEREAS, it is the Barangay Tanod Brigade of Brgy. Ipil that has
taken charge of the trucks and heavy equipments which are passing
through the said Barangay Street;

WHEREAS, the Barangay Council of Ipil has carried out that the
sharing of said toll fees collection shall be that 60% thereof be set
aside for the improvement of the street and 40% be for the Barangay
Tanod Brigade as their allowances;

WHEREAS, the aforementioned sharing of toll fees collection is
reasonable and within the powers and duties of a Barangay Council;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman,
Committee on Rules and Ordinances, duly seconded by Kagawad Nelson L.
Geneston; be it

RESOLVED, to approve Resolution No. 12-90 of the Sangguniang Barangay of Ipil, Ormoc City, re Sharing of the collection of P5.00 Toll Fee to be collected per Heavy Truck and/or Heavy Equipment passing through the Barangay Street of Brgy. Ipil, 60% of which to be set aside for the improvement of the street and 40% will be for the Barangay Tanod Brigade as their Allowances;

ENACTED, March 15, 1990.
