A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN OF ORMOC CITY, TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT WITH THE CIVIL BERVICE COMMISSION RELATIVE THE LATTER'S PROPOSAL TO OREN A CSC PROVINCIAL FIELD OFFICE IN ORMOC CITY.

WHEREAS, a letter dated February 27, 1990 from Director E. S. Gatchalian, Regional Director, Civil Service Commission, Tacloban City, addressed Her Honor, the City Mayor, the latter having endorsed said letter to the Honorable Sangguniany Panlungsod for appropriate legislative action, the same letter having submitted of a proposal for an opening of a CSC Provincial Field Office in Ormoc City, the full text of said letter is nereunder cited as follows:

Dear Mayor Locsin;

In response to its mandate and to bring the government closer to the people, the Civil Service Commission recently established five (5) field

offices and hope to open soon two (2) more in Region VIII. These field offices shall perform the following functions pursuant to Section 18; Chapter 4 of Executive Order No. 292:

- Provide technical assistance in all aspects of personnel management;
- 2. Monitor and audit periodically the personnel practices and performance of the Department or agency concerned as well as those of public officers and employees thereat:
- Determine compliance with Civil Service Law and rules;
- 4. In the performance of these functions, they shall welcome and receive from the public any suggestions, observations and complaints pertaining to the conduct of public officers and employees.

In this connection, may we inform you that we have chosen Ormoc City as the seat of one of the two (2) field offices that we are going to open. This field office will not only serve the City of Ormoc but its neighboring towns as well.

We are also enclosing a draft of the Memorandum of Agreement for your perusal. Said Memorandum of Agreement draws its legal basis on the pertinent portion of Section 18, Chapter 4 of Executive Order No. 292, as follows: "The Civil Service Commission shall, whenever it deems in the interest of the public service, organize in each $\times \times \times$ province and city government a Civil Service Staff which shall be headed by an officer of the Commission. The necessary staff personnel and office facilities and equipment shall be provided by the $\times \times \times \times$ local government where the staff is established but the Commission may augment these with its own- $\times \times$."

Should you find our proposal agreeable, we suggest that the same be submitted to the Sangguniang Panlungsod for deliberation and approval thru a resolution.
