RESOLUTION NO. 37

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P10,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND, UNDER MANAGEMENT TOOL ACCOUNT, SAID AMOUNT TO BE MADE AVAILABLE TO DEFRAY THE EXPENSES THAT WILL BE INCURRED IN FORTHCOMING SEMINAR-WORKSHOP ON FISHERY LAWS/ENFORCEMENT AND TRAINING/DEPUTIZATION OF FISHERY WARDENS ON MARCH 27 TO 29, 1990 AT ORMOC CITY TECHNOLOGICAL MANPOWER TRAINING & RESEARCH CENTER (OCTMTRC).

WHEREAS, this august Body is in receipt of Resolution No. 1 s. 1990 from the City Agriculture & Fishery Council (CAFC), a non-funded NGO in Ormoc City, requesting funding assistance from the City Government through Her Honor, the City Mayor for their Seminar-Workshop on Fishery Laws/Enforcement and Training/Deputization of Fishery Wardens on March 27 to 29, 1990 at Ormoc City Technological Manpower Training & Research Center (OCTMTRC);

WHEREAS, per their submitted training module and budgetary requirement, the aforecited training/seminar will be conducted by the City Agriculture and Fishery Council through the Department of Agriculture (DA) District Office, Ormoc City, in support to the City Government relative controlling/minimizing continued destruction/degradation of marine resources through destructive and illegal fishing practices, and on the deputization of all trainees-graduates of the seminar as Fishery Wardens to corresponding coastal barangays in Ormoc City through thier respective barangay chairmen/captains;

WHEREAS, this august Body believes that the said seminar-workshop is very significant in acquiring thorough knowledge relative protecting our marine products and resources in which enforcement of fishery laws plays a major role;

(RES. NO. 37)

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD, in SESSION, in keeping with the Program of the City Government for continuous and immediate services to its constituents, has enacted Resolution No. 36 embodying Appropriation Ordinance No. 90-14, (in Item B thereof), (a copy of this resolution is hereto attached), approving IN PRINCIPLE of an appropriation of TEN THOUSAND PESOS, (P10,000.00), from out of the 20% Economic Development Fund, under Management Tool account, said amount to be defrayed on inevitable expenses re aforesaid seminar-workshop, SUBJECT, HOWEVER, to an authority granted for this purpose by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., jointly seconded by mga Kagawad Arnulfo C. Salazar and Celso P. Porcadilla; be it

RESOLVED, to pass a resolution REQUESTING the DEPARTMENT OF LOCAL GOVERNMENT through DIRECTOR RESURRECCION S. SALVATIERRA, Regional Director, DLG, Region VIII, Tacloban City, TO AUTHORIZE the HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P10,000.00 from out of the 20% ECONOMIC DEVELOPMENT FUND (EDF), under MANAGEMENT TOOL ACCOUNT, said amount to be made available to defray the expenses that will be incurred in forthcoming SEMINAR-WORKSHOP on FISHERY LAWS/ENFORCEMENT AND TRAINING/DEPUTIZATION OF FISHERY WARDENS on March 27 to 29, 1990 at the Ormoc City Technological Manpower Training & Research Center;


