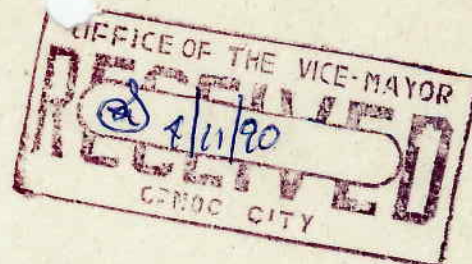
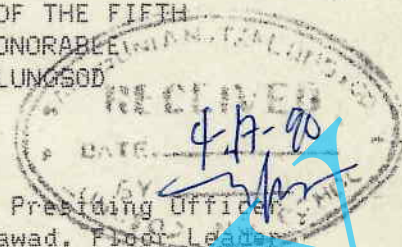

RESOLUTION NO. 39

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P140,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), SAID AMOUNT TO BE MADE AVAILABLE AS LOCAL COUNTERPART FUNDING FOR THE NALGU RELEASE OF P296,000.00, TO COMPLETE THE CONSTRUCTION OF THE MARKET ADMINISTRATION BUILDING IN ORMOC CITY PROGRAMMED AT P436,000.00.

WHEREAS, Her Honor, the City Mayor, has requested in writing the Honorable Sangguniang Panlungsod ng Ormoc through the Honorable Chairmen, Committees on Finance, Infrastructure, and on Market & Slaughterhouse, for supplementary appropriation of P140,00.00 as local counterpart funding for the NALGU release of P296,000.00, to complete the construction of the Market Administration building located at Ormoc public market;

WHEREAS, the City Engineer's Office has submitted a detailed program of work, estimates and plans showing that the subject building would cost at P436,000.00;

WHEREAS, the City Budget Officer, reiterating the recommendation of the Honorable City Mayor, has recommended that the funding requirement of P140,000.00 as local counterpart funding for the NALGU release of P296,000.00, to pursue construction of the subject Market Administration building be taken from the 20% Economic Development Fund (EDF);

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD, in SESSION, in keeping with the Program of the City Government for continuous and immediate services to its constituents, has enacted Resolution No. 38 embodying Appropriation Ordinance No. 90-15, (in Item D thereof), (a copy of this resolution is hereto attached), approving IN

(RES. NO. 39)

PRINCIPLE of an appropriation of ONE HUNDRED FORTY THOUSAND PESOS, (P140,000.00), from out of the 20% Economic Development Fund to be made available as local counterpart funding to complete the construction of the Market Administration building in Ormoc City, subject, however, to passage of a resolution requesting DLG authority for this utilization;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., jointly seconded by mga Kagawad Arnulfo C. Salazar and Celso P. Porcadilla; be it


RESOLVED, to request the Department of Local Government through Director Resurreccion S. Salvatierra, Regional Director, DLG, Region VIII, Tacloban City, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P140,000.00 from out of the 20% ECONOMIC DEVELOPMENT FUND to be made available as LOCAL COUNTERPART FUNDING for the NALGU release of P296,000.00, to COMPLETE THE CONSTRUCTION OF THE MARKET ADMINISTRATION BUILDING in Ormoc City, programmed at P436,000.00;

ENACTED, April 5, 1990.

RESOLVED, FURTHER, to furnish copies of this resolution one each to the Department of Local Government through Regional Director Resurreccion S. Salvatierra, DLG, Region VIII, Tacloban City; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; the City Treasurer, the City Budget Officer and the Acting City Government Operations Officer - DLG, -all in Ormoc City;
