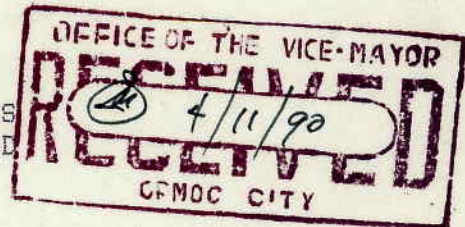

RESOLUTION NO. 40

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC, HONORABLE MA. VICTORIA L. LOCSIN, TO ENTER INTO A CONTRACT WITH FAR EAST CORPORATION RELATIVE SOIL INVESTIGATION, EXPLORATION AND TESTING SERVICES IN CONNECTION WITH PLANNED CONSTRUCTION OF THE PROPOSED MULTI-PURPOSE GYMNASIUM.

WHEREAS, Resolution No. 29 s. 1990 of the Sangguniang Panlungsod ng Ormoc has authorized the City Mayor to enter into a contract with Far East Corporation for the preparation of the detailed plans, specifications and estimates and for construction supervision services of the proposed multi-purpose gymnasium at the government center, Barangay Cogon, this city;

WHEREAS, the aforementioned resolution, however, does not mention or include provisions to a contract pertaining to soil exploration, investigation and testing services and, which exclusion of these kinds of services in the terms of the contract has the assent of PBAC, or the Prequalification, Bids, and Awards Committee;

WHEREAS, for further development, DPWH has submitted a higher proposal of P158,400.00 for six (6) boreholes at twenty (20) feet deep, and, the Far East Corporation, on the other hand, has submitted a proposal for P140,000.00 for six (6) holes at forty (40) feet;

WHEREAS, the PBAC, in its meeting on March 30, 1990, has agreed and decided to award the contract for soil investigation, exploration and soil testing services to Far East Corporation;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws & Ordinances, joint seconded by mga Kagawad Celso P. Adolfo and Jose B. Conejos; be it


