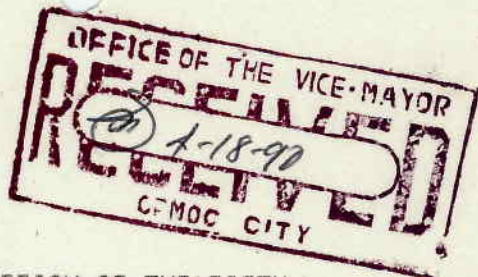

Barangay";

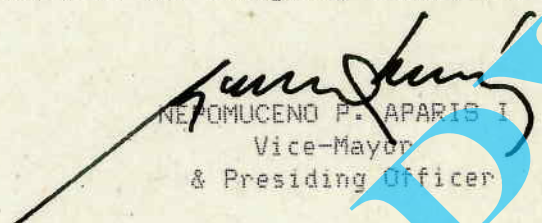

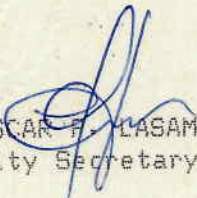

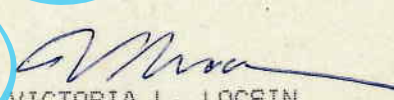
