

RESOLUTION NO.

A FOLLOW-UP RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, TO DECLARE JUNE 29TH OF EVERY CALENDAR YEAR A SPECIAL NON-WORKING HOLIDAY IN ORMOC CITY, THE SAME BEING THE CITY FIESTA CELEBRATION IN HONOR OF PATRON SAINTS PETER AND PAUL.

WHEREAS, Resolution No. 89 s. 1989 of the Sangguniang Panlungsod ng Ormoc has then earnestly requested Her Excellency, President Corazon C. Aquino, to declare June 29th of every calendar year as a Special Non-Working Holiday in Ormoc City, it being the City Fiesta celebration of said place in honor of Patron Saints Peter and Paul;

WHEREAS, according to records on file, the aforesaid resolution has been subitted on June 26. 1989, the same being acknowledged received on June 30, 1989 by Technical Assistant Maria Asuncion Fernando, Correspondence Office, Office of the President of the Philippines and, that said Office has further referred through Memorandum dated June 30th to Honorable Magdangal B. Elma, Deputy Executive Secretary, from there and up to now, no communication relative its further development has been received by this august Body;

WHEREAS, currently, the Honorable City Mayor of Ormoc, in her letter dated April 5, 1990, addressed the Honorable Sangguniang Panlungsod, has requested for passage of a resolution earnestly requesting Her Excellency, the President of the Philippines, to declare June 29 of each year a Special Non-Working Holiday for Ormoc City in order to give its people, in keeping with its cultural and traditional heritage, a chance to enjoy and reflect on the significance of the day as a fitting tribute to its Patron Saints;

WHEREAS, in order to justifiably provide the people of Ormoc City of the desired chance and resolve for a festive celebration and

merriment, it is necessary and important that all government employees, both in national and local levels in Ormoc City, be afforded a FREE day;

WHEREAS, the declaration of a non-working holiday is within the powers and prerogatives of the President of the Philippines as Chief Executive of the land.

NOW, THEREFORE, on motion of Kagawad Nelson L. Geneston, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Gregorio A. Yrastorza, Jr. and Celso P. Porcadilla; be it
