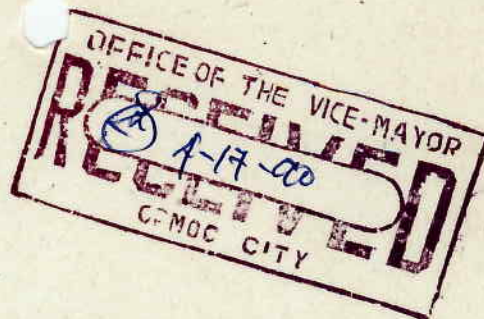

RESOLUTION NO. 43

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC, TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A LEASE APPLICATION WITH BRGY. DON FELIPE LARRAZABAL PRIMARY MULTI-PURPOSE COOPERATIVE, INC., OVER A PORTION OF THE PROPOSED CITY GOVERNMENT STORAGE BUILDING AT THE PUBLIC MARKET, FOR THE ASSOCIATION'S MINI-ICE PLANT AND STORAGE PROJECT.

WHEREAS, a letter dated March 31, 1990 from Mr. Arturo Asensi, Chairman, Brgy. Don Felipe Larrazabal Primary Multi-Purpose Cooperative, Inc., addressed the Honorable Sangguniang Panlungsod through Her Honor, the City Mayor, said letter runs in portion as follows:

" X X X , the Brgy. Don Felipe Larrazabal Primary Multi-Purpose Cooperative, Incorporated, has requested the National Agricultural & Fishery Council (NAFC), through the Livelihood Enhancement for Agricultural Development (LEAD)/ Buklod Yaman Project a Seed Capital in the amount of Three Hundred Fifty Five Thousand Pesos, (P355,000.00), for our Mini-Ice Plant and Storage Project. However, our request was held pending upon submission of the letter of assurance for the lease of the city government to the association of the proposed area, the propose storage of the city government building at the public market. X X X X .

" X X X , we officers and members of the association do hereby earnestly and most respectfully request the Honorable Body of Sangguniang Panlungsod of Ormoc through Honorable Ma. Victoria L. Locsin, City Mayor, to lease the portion of the proposed city storage building to the Brgy. Don Felipe Larrazabal Primary Multi-Purpose Cooperative, Inc., for the

Mini-Ice Plant and Storage Project of the above organization."

WHEREAS, in the 1st Indorsement dated April 10, 1990 of the Honorable Acting City Mayor, vice Her Honor, the City Mayor, the latter being Out-of-Town on official business, it has stated that the rate and term of said lease contract be decided by an appropriate committee of this honorable august Body;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., duly seconded by Kagawad Celso P. Porcadilla; be it



Don Felipe Larrazabal Primary Multi-Purpose Cooperative, Inc., over a portion of the Proposed City Government Storage building at the public market, for the association's Mini-Ice Plant and Storage project;
