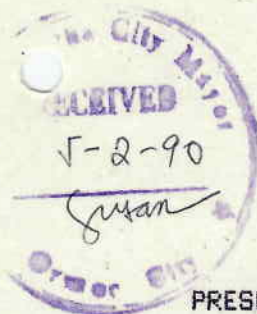

RESOLUTION NO. 47

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR TO UTILIZE THE AMOUNT OF P28,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE TO DEFRAY THE EXPENSES TO BE INCURRED IN CONDUCTING SKILLS TRAINING OF BARANGAY TREASURERS (BARANGAY ADMINISTRATION TRAINING PHASE III), TENTATIVELY SCHEDULED MARCH 29-30, 1990, CITY CENTRAL SCHOOL, ORMOC CITY.

WHEREAS, the Sangguniang Panlungsod is in receipt of a letter dated March 1, 1990 from Mr. R. A. Torcende, ACGOO - DLG, this city, requesting for appropriation amounting to P28,000.00 to defray for the expenses to be incurred in conducting Skills Training of the Barangay Treasurers in Ormoc City, (Barangay Administration Training - Phase III), tentatively scheduled March 29 - 30, 1990 at the City Central School, this city, with the following breakdown:

WHEREAS, the City Budget Officer has recommended that the funding requirement of the aforesaid request of P28,000.00 for the Skills Training of Barangay Treasurers in Ormoc City be sourced from the 20% Economic Development Fund of the General Fund;

WHEREAS, this august Body believes that skills training of this kind among the Barangay Treasurers is important so that they could acquire the ability and expertise in the preparation of financial plans, on filling up of accountable and other related forms for which their office is expected to perform and, develop competence and efficiency in their works, for, these people are accountable, at all times, to their respective constituents in particular and the public in general;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has enacted Resolution No. 46 embodying Appropriation Ordinance No. 90-17 (Item A), (a copy of same is hereto attached), approving IN PRINCIPLE of an appropriation of TWENTY EIGHT THOUSAND PESOS, (P28,000.00), from out of the 20% Economic Development Fund (EDF), said amount to be made available to defray the expenses to be incurred in conducting Skills Training of Barangay Treasurers in Ormoc City, subject, however, to the approval by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Eufrocino C. Codilla, Jr.; be it



Salvatierra, DLG, Region VIII, Tacloban City, to authorize the Honorable City Mayor of Ormoc City to utilize the amount of P28,000.00 from out of the 20% Economic Development Fund, the same amount to be made available to defray the expenses to be incurred in conducting Skills Training of Barangay Treasurers (Barangay Administration Training - Phase III), tentatively scheduled March 29-30, 1990 at the City Central School, Ormoc City;
