RESOLUTION NO. 50

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF P3,829.50 AGAINST CURRENT APPROPRIATION OF THE CITY TREASURER'S OFFICE, SAID AMOUNT TO REPRESENT PAYMENT OF TRAVELLING EXPENSES INCURRED BY F. C. JABILLES, ACCTG. CLERK II - CTO, IN GOING TO AND FROM MANILA IN CONNECTION WITH HIS ATTENDANCE TO A CRIMINAL CASE FILED AGAINST HIM BEFORE THE SANDIGANBAYAN, AND SUBSEQUENTLY WAS ACQUITTED OF SAID CHARGE OR ACCUSATION BY THE SAME COURT.

WHEREAS, the City Treasurer has written a letter dated April 23, 1990 addressed Her Honor, the City Mayor, the latter having endorsed the same to the Honorable Sangguniang Panlungsod for legislative action, said letter baying requested for additional appropriation amounting to P3,829.50 to be taken from the Unappropriated Surplus of the General Fund for payment of the travelling expenses incurred by Francisco C. Jabilles, Acctg. Clerk II - CTO, in going to and from Manila; during suspension period effective April 18, 1989 due to a criminal charge filed against him before the SANDIGANBAYAN, to secure attendance before said Sandiganbayan, which court, however, having subsequently acquitted F. C. Jabilles of the same charge or accusation and, in effect has lifted his suspension pursuant to Sec. 13 of Rep. Act No. 3019 as amended, and, alleging therein as exhibit, Revised Manual of Instruction to Treasurers, page 554 par. (b) thereof having stated, "When officer of employee is the respondent or accused: The attendance of officer or employee in court X X X in his own behalf when he is the accused or respondent, to secure his exoneration of the charges or matter alleged against him is attendance for his own benefit. Travel expenses incurred by him on account of such attendance shall, therefore, in the first instance be his own private expense. In the case of acquittaal or exoneration, however, where the criminal charges filed, or the matter charged, against him are the direct result of an act performed by him in connection with his appearance in court X X X shall be reimbursable to

him, the same as travelling expenses incurrent in the performance of official duty. X X X X";

WHEREAS, the City Budget Officer has recommended that the financial requirement of the subject amount of P3,829.50 for payment of F.C. Jabilles' travel expenses be charged against the 1990 appropriation for Travelling Expenses of the Office of the City Treasurer;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Rodolfo L. Rivilla, Jr., be it

RESOLVED, to authorize the City Treasurer to charge the amount of P3,829.50 against Current Appropriation of the City Treasurer's Office, said amount to represent payment of the travelling expenses incurred by F.C. Jabilles, Acctg. Clerk II, CTO, in going to and from Mapila in connection with his attendance to a criminal case filed against him before the Sandiganbayan, and subsequently was acquitted of said charge or accusation by the same Court;
