

## RESOLUTION NO. 56

WHEREAS, this august Body bears the shock with which it takes the news of the death of a highly esteemed former Councilor of the previous Municipal Board of Ormoc City, now the Sangguniang Panlungsod ng Ormoc. Honorable PABLO S. PAJARUN, who succumbed in the early morning last May 7, 1990;

Pajaron, with his dedication, vision and commitment to his job as the former Councilor of Ormoc City, had won for himself the distinction of a scrupulous worker and a devoted public servant, faithful to his avowed duties and responsibilities and, had a lot helped Ormoc City to its present status of a peaceful, progressive and beautiful city:
