RESOLUTION NO.

A RESOLUTION APPROVING AND ADOPTING RESOLUTION NO. 4 S. 1990 OF THE DEVELOPMENT COUNCIL RELATIVE ITS RECOMMENDED PROJECTS TO BE FUNDED UNDER THE BUDGETARY ALD TO LOCAL GOVERNMENT UNITS, (BALGU).

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of Resolution No. 4 sf 1990 from the City Development Council (CDC) endorsing, for approval and adoption purposes, the following recommended projects to be funded under BALGU Fund allotment for Calendar Year 1990 to Ormoc City, to wit:

> 1) Construction of Brgy. Liberty Timber Trestle Bridge P220,000.00

2) Repair & Maintenance of Brgy. Manlilingo Bailey Bridge

Construction of Box Culvert and Drainage along Brgy. Alegria Road -

> Total . . . P 899,000.00 VAAAAAAAAAAA

WHEREAS, said CDC Resolution No. 4 has further alleged that "since bhe total amount needed for these projects is in excess of the BALGU fund ceiling of P800,000.00 allotted for the city, the City Development Council has agreed to request the Hon. Carmelo J. Locsin, Congressman, Fourth District of Leyte, through CDC Resolution No. 3, Series of 1990, the amount of P100,000.00 to be taken from out of the P769,000.00 BALGU fund allotted for the District, to offset the deficit of P97,000.00 (SAY: P100,000.00), if only for the complete implementation of the above-named projects";

WHEREAS, this august Body has conformed with the CDC's finding, identifying and prioritizing the aforecited projects to the barangays concerned as the most basic needs in these barangays;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Rodolfo L. Rivilla, Jr., be it

RESOLVED, to approve and adopt Resolution No. 4 s. 1990 of the City Development Council (CDC) pertaining to its Recommended Projects to be funded under the Budgetary Aid to Local Government Units (BALGU), namely:

- a) Construction of Brgy- Liberty Timber Trestle Bridge
- b) Repair & Maintenance of Brgy-Manlilinao Bailey Bridge, and
- c) Construction of Box Culvert and Drainage along Brgy. Alegria Road
