WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of Resolution No. 4 s. 1990 from the City Development Council (CDC) endorsing, for approval and adoption purposes, the following recommended projects to be funded under BALGU Fund allotment for Calendar Year 1990 to Ormoc City, to wit:


- a) Construction of Brgy. Liberty Timber Trestle Bridge
