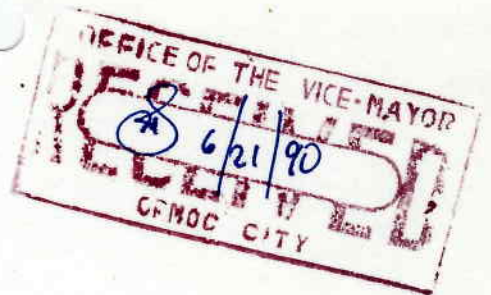

RESOLUTION NO. 64

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR TO UTILIZE THE AMOUNT OF P40,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) TO BE MADE AVAILABLE FOR INTER-BARANGAY SPORTS TOURNAMENT.

WHEREAS, this august Body is in receipt of a letter dated June 11, 1990 from the Honorable Nelson DL. Geneston, Kagawad, Sangguniang Panlungsod ng Ormoc, requesting an appropriation in the amount of P70,000.00 as prizes for the inter-barangay sports tournament;

WHEREAS, the Chairman on Finance endorsed said letter to the City Budget Officer, informing her that only P40,000.00 is recommended for funding to serve the purpose;

WHEREAS, the City Budget Officer has reiterated the suggested amount of P40,000.00 and further recommended that financial requirement of same amount be funded from the 20% Economic Development Fund (EDF), subject, however, to a request for authority relative its utilization from the Department of Local Government;

WHEREAS, this august Body believes that this athletic competition to be undertaken is very much important among barangay folks because its aim is to develop the talent of the youth in the barangay so that they will become useful citizens in the community;

WHEREAS, the Honorable MEMBERS of the Sangguniang Panlungsod ng Ormoc, in SESSION, has enacted Resolution No. 63 embodying Appropriation Ordinance No. 90-25 (a copy of same is hereto attached), approving IN PRINCIPLE of an appropriation of FORTY THOUSAND PESOS & 00/100, (P40,000.00), from out of the 20% Economic Development Fund (EDF), said amount to be made available for the inter-barangay sports tournament subject, however, to the approval by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., duly seconded by Kagawad Rodolfo L. Rivilla, Jr.; be it


RESOLVED, to request the Department of Local Government through the Regional Director Resurreccion S. Salvatierra, DLG, Region VIII, Tacloban City, to authorize the Honorable City Mayor of Ormoc City to utilize the amount of P40,000.00 from out of the 20% Economic Development Fund (EDF), same amount to be made available for the inter-barangay sports tournament.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Department of Local Government through Director Resurreccion S. Salvatierra, Regional Director, DLG, Tacloban City; Hon. Ma. Victoria L. Locsin, City Mayor, Ormoc City; the City Treasurer, and the City Budget Officer, - all in Ormoc City;
