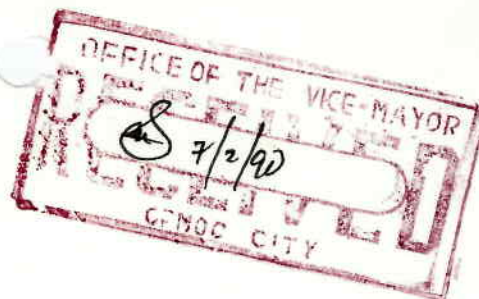

RESOLUTION NO. 45

A RESOLUTION FULLY ENDORSING AND SUPPORTING RESOLUTION NO. 90-089 OF THE SANGGUNIANG PANLUNGSOD NG NAGA REQUESTING CONGRESS OF THE PHILIPPINES THROUGH SENATE PRESIDENT JOVITO SALONGA AND SPEAKER RAMON MITRA TO CONSIDER THE ENACTMENT OF A LAW EXEMPTING BONUSES, REPRESENTATION AND TRANSPORTATION ALLOWANCES, AND CASH GIFTS FROM THE COMPUTATION OF INDIVIDUAL INCOME TAX RETURN.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 90-089 s. 1990 of the Sangguniang Panlungsod of Naga City, requesting Congress of the Philippines through Senate President Jovito Salonga and Speaker Ramon Mitra to consider the enactment of a law exempting Bonuses, Representation and Transportation Allowances and Cash Gifts from the computation of Individual Income Tax Return;
