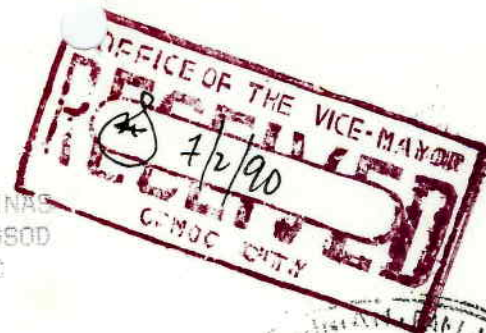

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF P2,705.00 REPRESENTING PAYMENT OF PER DIEMS TO MR. B.D. SUPREMO, CITY ASSESSOR, FOR NOVEMBER AND DECEMBER, 1989, AGAINST CURRENT APPROPRIATION FOR TRAVELLING EXPENSES OF THE CITY ASSESSOR'S OFFICE.

WHEREAS, Mr. B.D. Supremo, City Assessor, through a letter dated May 24, 1990 addressed to the Honorable Sangguniang Panlungsod through Her Honor, the City Mayor, has requested that unpaid per diems for him in the amount of P2,705.00 for the months of November and December, 1989, be charged against current allotment of the City Assessor's Office;

WHEREAS, the City Treasurer, in his 4th Indorsement dated June 11, 1990, has favorably recommended for appropriation of the subject request of the City Assessor for P2,705.00;

WHEREAS, the City Budget Officer has recommended that the unpaid per diems, as claimed by the City Assessor, for the months of November and December, 1989 in the amount of P2,705.00 be charged against Current Appropriation for Travelling Expenses of the City Assessor's Office;


