RESOLUTION NO. 68

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P256,150.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE FOR THE REPAIR OF ORMOC TERMINAL BUILDINGS I AND II.

WHEREAS, this august Body is in receipt of a letter dated May 21, 1990 from the City Engineer through Her Honor, the City Mayor of Ormoc, said letter, complete with enclosures of a duly approved Program of Work and with Detailed Estimates, (contents of which please refer to Resolution No. 67 s. 1990 creating Appropriation Ordinance No. 90-26, hereto attached), having requested for an appropriation of P256,150.00 for the repair of roofing/immediate replacement of deteriorated and leaking roofing sheets of Terminals I and II this city;

WHEREAS, as recommended by the City Budget Officer, the financial requirement of said appropriation of P256,150.00 for the Repair of Ormoc Terminal Buildings I and II be funded from out of the 20% Economic Development Fund (EDF) of the General Fund;

WHEREAS, this august Body has conformed to the fact that this project on the repairs of Ormoc Terminal Buildings I and II would prove beneficial "not only for the comfort of the travelling public using these terminal buildings, but also for the prevention of further damage to the buildings especially the purlins and trusses which are of iron materials", hence, has enacted Resolution No. 67 embodying Appropriation Ordinance No. 90-26 approving IN PRINCIPLE on appropriating P256,150.00, however, subject to the approval by the Department of Local Government;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Arnulfo C. Salazar; be it


