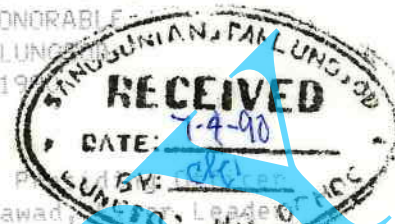
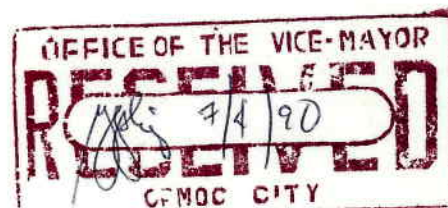

WHEREAS, a DEED OF DONATION is now being prepared to be signed by Her Honor, Mayor Ma. Victoria L. Locsin, for and in behalf of the City of Ormoc with the City of Bacolod regarding a donation of one (1) unit Isuzu Bus with Engine No. DA-640 352749;

WHEREAS, the City of Ormoc is a recipient of five (5) units motor vehicles donated from the City of Kaohsiung, Republic of China, through the City Government of Cebu, described as follows:

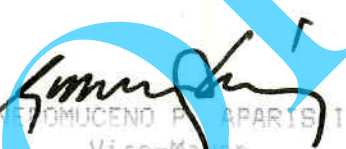
