RESOLUTION NO. 71

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT  
THROUGH ITS REGIONAL DIRECTOR, TACLOBAN CITY, TO AUTHORIZE THE  
HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P100,000.00  
FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) TO BE MADE  
AVAILABLE FOR THE REPAIR OF SITIO ISLA VERDE FOOTBRIDGE.

WHEREAS, this august Body is in receipt of a Resolution No. 2,  
Series of 1990 of the City Development Council earnestly requesting the  
Honorable Sangguniang Panlungsod ng Ormoc to appropriate the amount of  
P100,000.00 for the repair of Sitio Isla Verde Footbridge, said amount  
to be taken from the 20% Economic Development Fund, (EDF);

WHEREAS, the Honorable Committee on Finance, chaired by the Hon.  
Sixto T. Pongos has endorsed the same to the City Budget Officer for  
comment and recommendation;

WHEREAS, the City Budget Officer has recommended that the financial  
requirement of P100,000.00 for the repair of Sitio Isla Verde  
Footbridge, be funded from the 20% Economic Development Fund of the  
General Fund, subject to a resolution requesting DLG authority for this  
utilization;

WHEREAS, this august Body believes that if Sitio Isla Verde  
Footbridge would not be repaired no doubt this becomes hazardous to the  
lives and limbs of many commuters passing to and from Sitio Isla Verde  
at the opposite bank of the river, hence, requiring for immediate  
attention and consideration;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng  
ORMOC, in SESSION, has enacted Resolution No. 70 embodying  
Appropriation-Ordinance No. 90-27 (Item A), (a copy of same hereto

attached), approving in PRINCIPLE of an appropriation of ONE HUNDRED THOUSAND PESOS & 00/100, (P100,000.00), from out of the 20% Economic Development Fund (EDF), said amount to be made available for the repair of Sitio Isla Verde Footbridge;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR RESURRECCION S. SALVATIERRA, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC CITY TO UTILIZE THE AMOUNT OF P100,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), the same amount to be made available for the repair of Sitio Isla Verde Footbridge;
