RESOLUTION NO. 72

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EFFECT AN INTERFUND TRANSFER FROM THE GENERAL FUND TO INFRASTRUCTURE FUND IN THE AMOUNT OF P500,000.00, AS LOCAL COUNTERPART REQUIREMENT FOR THE COMPLETION OF THE EXECUTIVE BUILDING (PHASE II).

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of a letter dated June 25, 1990 from the Honorable City Mayor Ma. Victoria L. Locsin, requesting a supplemental appropriation of P500,000.00, as local counterpart requirement for the completion of the Executive Building (Phase II); considering that the P2.0M which was recently received by her thru Advice of Allotment No. BCS-011-90-215 dated June 6, 1990, which was sourced from the Countrywide Development Fund of the Honorable Carmelo J. Locsin, Congressman, 4th District, Leyte is not enough to serve the purpose;

WHEREAS, per detailed estimates by the Office of the City Engineer the initial amount for the construction cost will amount to P2.5M due to the spiralling cost of labor and materials while available funding is only P2.0M or a shortfall of P500,000.00;

WHEREAS, the City Budget Officer has recommended that the local counterpart requirement of P500,000.00 for the completion of the Executive Building (Phase II) be sourced from the Unappropriated Surplus of the General Fund;

WHEREAS, the Honorable MEMBERS of the Sangguniang Panlungsod ng Ormoc, in SESSION, has enacted Resolution No. 70 embodying Appropriation-Ordinance No. 90-27 (Item C) approving in PRINCIPLE of an appropriation of FIVE HUNDRED THOUSAND PESOS & 00/100, (P500,000.00), said amount to be made available as local counterpart requirement for the completion of the Executive Building (Phase II);

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to pass a resolution AUTHORIZING THE CITY TREASURER TO EFFECT AN INTERFUND TRANSFER FROM THE GENERAL FUND TO INFRASTRUCTURE FUND IN THE AMOUNT OF P500,000.00, said amount to be made available as local counterpart requirement for the completion of the Executive Building (Phase II);

ENACTED, June 27, 1990.

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor, the City Treasurer and the City Budget Officer, - all in Ormoc City;

CARRIED. Six affirmative votes, four against by mga Kagawad Eufrocino C. Codilla, Jr., Jose B. Conejos, Benjamin F. Tugonon, and Antero T. Fiel.
