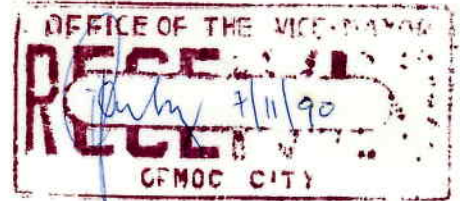
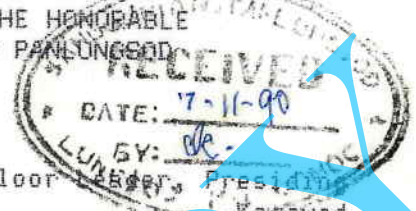

RESOLUTION NO. 74

A RESOLUTION EXPRESSING OUR SUPPORT TO RESOLUTION NO. 362, S. 1990 OF THE SANGGUNIANG PANLUNGSOD NG DAVAO FOR APPROVAL OF SENATE BILL NO. 801, AUTHORED BY SENATOR JOSE LINA, JR.

WHEREAS, this august Body is in receipt of Resolution No. 362, s. 1990 of the Sangguniang Panlungsod ng Davao, expressing the Body's support to Senate Bill No. 801, authored by Senator Jose Lina, Jr. seeking to establish a massive program for barangay day care centers in the 4,270 barangays throughout the country to check the mounting incidence of disease, malnutrition, delinquency and illiteracy affecting some 11 million Filipino children below five years of age;

WHEREAS, this august Body conforms to the embodiment of the aforesaid resolution of the Sangguniang Panlungsod ng Davao;
