RESOLUTION NO. 75

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO FORMALLY ADVISE FAR EAST CORPORATION TO PREPARE THE FINAL DESIGN OF THE PROPOSED MULTI-PURPOSE GYMNASIUM BASED ON THE PRELIMINARY DESIGN BUT THE SAME SHOULD BE LIMITED TO THE BUILDING EXCLUDING ALL EXTERIOR FACILITIES.

WHEREAS, this august Body is in receipt of a communication from Her Honor, the City Mayor, addressed through the Honorable Chairman, Committee on Infrastructure, which letter is quoted hereunder, thus:

Gentlemen:

Far East Corporation submitted as stipulated in our contract, a preliminary design and estimates of the proposed multi-purpose

gymnasium, which was discussed in a meeting last June 13, 1990. The project, which has a capacity of about 8,000 persons, is estimated to cost about P38.0M plus.

Considering our funding limitations, we requested Far East Corporation to come out with alternative proposals for our consideration. They submitted estimates as follows:

Scheme 1 - P22M for 1,345 person capacity gymnasium

Scheme 2 - P22.5M for a 1,799 person capacity gymnasium

Considering that the reduction in cost vis-a-vis the reduction in capacity is not proportionate, it is recommended that we proceed with plans to construct an estimated P38M project per preliminary design submitted.

It is respectfully requested that a resolution be passed authorizing the undersigned to formally advise Far East Corporation to prepare the final design of the proposed multi-purpose gymnasium based on the preliminary design but the same should be limited to the building to exclude all exterior facilities.
