

RESOLUTION NO. 83

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT (DLG), THROUGH ITS REGIONAL DIRECTOR, TAGLOBAN CITY, TO AUTHORIZE HONORABLE MA. VICTORIA L. LOCSIN, CITY MAYOR OF ORMOC, TO UTILIZE THE AMOUNT OF P151,771.18 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE FOR THE CONSTRUCTION OF A CURB, GUTTER AND SIDEWALK AT BARANGAY DISTRICT 12 ALONG LOPEZ JAENA STREET, ORMOC CITY.

WHEREAS, Her Honor, the City Mayor, has endorsed to this august Body for appropriate action, Resolution No. 001 s. 1989 of the PTA-SPC Board of Directors, said resolution having requested for the construction of a curb, gutter and sidewalk at Barangay District 12 along Lopez Jaena Street this city;

WHEREAS, it is true that as alleged in said resolution "the canal along Lopez Jaena Street at the back gate of Saint Peter's College is in a sad state of disrepair, that it is not covered thus has become an excellent breeding place for flies and mosquitoes due to its dirty and stagnant water, that the Kindergarten and Prep pupils at SPC whose gate is along Lopez Jaena Street are deprived of a sidewalk thus are exposed to traffic hazards and, that the construction of a curb, gutter and sidewalk along said street will make the area clean and sanitary";

WHEREAS, the City Engineer has submitted a duly accomplished and approved Program of Work and Detailed Estimates for the construction of a Curb, Gutter and Drainage with cover along Lopez Jaena Street with a total budget cost of One Hundred Fifty One Thousand Seven Hundred Seventy One Pesos & 18/100, (P151,771.18);

WHEREAS, this august Body, with the assent secured from the Officers of the City Development Council relative inclusion and priority on the use of the 20% EDF, (in line with Executive Order No. 319, Sec. 5 (v), dated 4 March 1989), has come to a consensus that the financial requirement of the subject appropriation of P151,771.18 for the

construction of a curb, gutter and sidewalk at Brgy. District 12 along Lopez Jaena Street be sourced from the 20% Economic Development Fund;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has enacted Resolution No. 82 embodying Appropriation Ordinance No. 90-30, (a copy of same is hereto attached), approving in PRINCIPLE of an appropriation of One Hundred Fifty One Thousand Seven Hundred Seventy One Pesos & 18/100, (P151,771.18), from out of the 20% Economic Development Fund, said amount to be made available for the construction of a curb, gutter and sidewalk along Lopez Jaena Street subject, however, to a passage of a resolution requesting the Department of Local Government with authority relative its utilization;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Eufrocino C. Codilla, Jr., be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH ITS REGIONAL DIRECTOR RESURRECCION S. SALVATIERRA, REGION VIII, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P151,771.18 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), the same amount to be made available for the construction of a Curb, Gutter and Sidewalk at Barangay District 12 along Lopez Jaena Street, Ormoc City;

ENACTED, July 19, 1990.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Department of Local Government through Director Resurreccion S. Salvatierra, Regional Director, DLG, Tacloban City; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; the City Treasurer, the City Budget Officer, and the City Engineer, - all in Ormoc City;

CARRIED. Nine (9) affirmative votes and two (2) abstentions, registered by mga Kagawad Celso P. Adolfo and Benjamin F. Tugonon.
