RESOLUTION NO. 85

A RESOLUTION REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT THROUGH
ITS REGIONAL DIRECTOR, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE
CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P1,700,000.00 FROM OUT
OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), TO BE MADE AVAILABLE
FOR THE PURCHASE OF TWO (2) UNITS ISUZU 10-WHEELER RECONDITIONED
DUMP TRUCKS FOR THE MAINTENANCE, IMPROVEMENT AND REPAIRS OF
BARANGAY ROADS.

WHEREAS, this august Body is in receipt of a letter from Her Honor,
the City Mayor, the full text of which is hereunder reflected as
follows:

Gentlemen:

The maintenance, improvement and repairs of barangay roads is one
of the foremost concern of this administration. A basic necessity of
this program however is the provision of hauling equipments for filling
and other necessary materials.

(RES. NO. 85)

Our equipment pool is critically outdated and inadequate to cope up with the needs of our barangays. It is recommended that the City purchase two (2) units Isuzu 10-wheeler reconditioned dump trucks to augment our aging fleet of trucks. These Japanese reconditioned units has a capacity of almost triple the load of our Leyland trucks which are most often bogged down due to the absence of replacement parts.

The trucks are estimated to cost about P 850,000 each; hence, an appropriation of P 1,700,000 is requested.

RESOLVED, to pass a resolution REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT, THROUGH ITS REGIONAL DIRECTOR, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P1,700,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF), TO BE MADE AVAILABLE FOR THE PURCHASE OF TWO (2) UNITS ISUZU 10-WHEELER RECONDITIONED DUMP TRUCKS FOR THE MAINTENANCE, IMPROVEMENT AND REPAIRS OF BARANGAY ROADS;
