RESOLUTION NO. 89

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF P4,765.50 FOR UNPAID TRAVELLING EXPENSES OF MR. B. D. SUPREMO, CITY ASSESSOR, FROM NOVEMBER 29 TO DECEMBER 2, 1989, AGAINST CURRENT APPROPRIATION FOR TRAVELLING EXPENSES OF THE CITY ASSESSOR'S OFFICE.

WHEREAS, this august Body is in receipt of a letter dated July 12, 1990 from Mr. B.D. Supremo, City Assessor, through the Honorable Office of the City Mayor, said letter having informed about the City Assessor's attendance of the 5th Asian Valuers Congress (November 29 to December 2, 1989 - Manila), and in conferring with Officials of the Bureau of Local Government Finance - Department of Finance - Manila, with attached Itinerary of Travel showing a total expenses incurred thereat in the amount of P4,765.50 personally paid by him, as alleged, "due to exhausted Funds", and highly requesting for authority to be granted the City Treasurer to charge said unpaid obligation to the current allotment of the City Assessor's Office;

WHEREAS, the City Treasurer, in his 1st Indorsement dated July 13, 1990, has recommended for a favorable action to the basic request of the City Assessor and, which recommendation has been reinforced per 2nd Indorsement dated July 17, 1990 of the Honorable City Mayor who also has recommended for favorable action to said request;

WHEREAS, the City Budget Officer has recommended that the financial requirement for the subject unpaid travelling expenses from November 29 to December 2, 1989 of the City Assessor in the amount of Four Thousand Seven Hundred Sixty Five Pesos & 50/100, (P4,765.50), be charged against Current Appropriation for Travelling Expenses of the City Assessor's Office;


