RESOLUTION NO. 91

A RESOLUTION EARNESTLY REQUESTING CONGRESS OF THE PHILIPPINES TO PASS  
A LAW GRANTING HONORARIA TO ALL THE BARANGAY TANODS THROUGHOUT THE  
PHILIPPINES.

WHEREAS, the Barangay Tanods are so essential in the maintenance of  
peace and order in a barangay, so that it becomes indispensable in every  
barangay organization to have them included as integral part thereto;

WHEREAS, the lives of the Barangay Tanods are, at all times,  
exposed to danger, for they are usually called upon to quell violence  
and disorder in every barangay, especially in far-flung barangays which  
are away from the protective umbrella of our peace and order forces;

WHEREAS, in order to animate enthusiasm and initiative in the  
Barangay Tanods to render faithfully their duties and services to the  
barangays, notwithstanding inescapable situation where life and limbs  
may be involved, it becomes incumbent on the conscientious public  
officials who are far-sighted and with deep concern for humanities  
happiness, to do something to alleviate the economic status of the  
Barangay Tanods to a degree a little bit better than the mere feeling of  
insecurity and of seeing their children hungry;

NOW, THEREFORE, on a joint motion presented to by mga Kagawad  
Rodolfo L. Rivilla, Jr. and Sixto T. Pongos, severally seconded by mga  
Kagawad Nelson DL. Geneston, Gregorio A. Yrastorza, Jr. and Arnulfo C.  
Salazar; be it

REQUESTING CONGRESS OF THE PHILIPPINES TO PASS A LAW GRANTING HONORARIA


Enacted, August 9, 1990.
