RESOLUTION NO.

A RESOLUTION ADOPTING AND SUPPORTING RESOLUTION NO. 9 S. 1990 OF THE BARANGAY COUNCIL OF LICUMA REDUESTING THE HONORABLE CITY MAYOR AND THE HONORABLE SANGGUNIANG PANLUNGSOD TO GIVE BARANGAY LICUMA WITH PRIORITY RIGHT TO APPLY OR CLAIM THE ABANDONED RIVER BED (PUBLIC LAND) ADJOINING THE BARANGAY AND SCHOOL SITES TO INCLUDE THE LAND (FORMERLY A RIVER BED) ON WHERE THE SCHOOL BUILDING OF THE BARANGAY IS WRONGLY ERECTED.

WHEREAS, this august Body is in receipt of Resolution No. 9 S. 1990 of the Barangay Council of Licuma, through Her Honor, the City Mayor, the latter having indorsed the same to the Honorable Sangguniang Panlungsod for appropriate action, said resolution having requested both the Honorable City Mayor and the Honorable Sangguniang Panlungsod to grant Barangay Licuma with priopity right to apply or claim the abandoned river bed or public land which is located adjoining the barangay and school sites including the land (formerly river hed) where the school building of the barangay is wrongly erected;

WHEREAS, as alleged in said resolution, Barangay Licuma has benefited from the national government of a 2-room school building which was erected sometimes in 1984; however, after the relocation of the site, it was found out that said school building was not erected inside the barangay site, that it was wrongly erected at an abandoned river bed or public land adjoining the site of the barangay;

WHEREAS, the Barangay Council of Licuma has made a formal request through its Resolution No. 9s 1990 for priority right to apply or claim the aforementioned abandoned river bed (public land) so that the same may be converted legally to a permanent school site - where the school building is wrongly situated;

WHEREAS, this august Body has considered the request of the Barangay Council of Licuma reasonable and, must be accorded with due course and favorable action;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, duly seconded by Kagawad Celso P. Adolfo; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to adopt and support Resolution No. 9 s. 1990 of the Barangay Council of Licuma re requesting the Honorable City Mayor and the Honorable Sangguniang Panlungsod to give Barangay Licuma with priority right to apply or claim the abandoned river bed or public land which is located adjoining the barangay and school sites, to include the land (formerly a river bed) where the school building of the barangay is wrongly erected;

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor; the Honorable Chairman, Committee on Public Properties; the Registrar - Register of Deeds; and, the Honorable Barangay Captain - Brgy. Licuma, - all in Ormoc City;
