A RESOLUTION HIGHLY REQUESTING AND URGING THE HONORABLE SENATE MAJORITY FLOOR LEADER TEOFISTO GUINGONA TO DEFER ANY DELIBERATION AND ACTION ON A PROPOSED BILL ALLOWING QUALIFIED VOTERS OF ORMOC CITY TO VOTE FOR PROVINCIAL OFFICIALS OF THE PROVINCE OF LEYTE.

Gentlemen:

The Senate is presently contemplating on a bill allowing qualified voters of Ormoc to vote for provincial officials of the Province of Leyte.

This would entail significant changes in our present set-up and as such would necessitate a thorough study and evaluation.

It is requested that a resolution be passed urging Senate Majority Floor Leader, Hon. Teofisto Guingona, to

defer any deliberations and action on the proposed bill until we have made a thorough evaluation of its advantages and disadvantages.
