A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN, TO ENTER HATO INTO A CONTRACT WITH GTX BUILDERS FOR THE CONSTRUCTION OF THE ORMOC CITY EXECUTIVE BUILDING PHASE II.

WHEREAS, in the biddings conducted last August 1 and 15, 1990 successively, no less than the GTX Builders hurdled as Winner being the lowest bidder to have quoted for the construction of the Ormoc City Executive Building - Phase II;

WHEREAS, there is now being prepared a CONTRACT for the purpose to be signed by Her Honor, the City Mayor, for and in behalf of the City of Ormor with the Management of GTX Builders;
