RESOLUTION NO. 01

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO GRANT EXTENSION
OF THE DEADLINE FOR REGISTRATION/RENEWAL OF PERMITS/LICENSING OF
BUSINESSES FROM JANUARY 20 TO FEBRUARY 15, 1991.

WHEREAS, the President of the Ormoc Filipino Retailers Association
has requested in writing the Honorable City Mayor for an extension of
the Deadline of Registration/Renewal of Permits/Licensing of businesses
from January 20 to February 15, 1991, allegedly due to financial
hardships being experienced by its members as after effect of typhoon
Ruping and due to the current increase of fuel prices;

WHEREAS, Her Honor, the City Mayor, has endorsed the aforesaid
request of said retailers association to the Honorable Sangguniang
Panlungsod for appropriate action, and, the latter has deliberated and
resolved as reasonable to temporarily suspend the operation of Section
1.2.1.4 of Tax Ordinance No. 1 s. 1976, otherwise known as the "Ormoc
City Revenue Code of 1977", fixing "the first twenty (20) days of
January" of every year within which to pay tax obligations to the
government, in order to provide not only the members of the aforementioned
association, but to all taxpayers with ample time to meet the various
requirements relative tax obligations;

WHEREAS, by way of precedence, generally the extension of deadline
so granted on payments of tax obligations to the government is only up
to the 31st day of January in every year, so that, by analogy, this
request at issue for an extension of said deadline UP TO FEBRUARY 15,
1991 is believed exceptional and needs the confirmation of the Honorable
City Mayor, for extension of a deadline of this nature is still within
the prerogative powers of the Local Chief Executive, provided based on
meritorious and justifiable reasons;


