A RESOLUTION EARNESTLY REQUESTING THE MANAGEMENT OF PHILIPPINE AIR LINES (PAL) TO CONTINUE SERVICING ORMOC-CEBU/CEBU-ORMOC ROUTE SO AS TO SERVE THE COMMUTING PUBLIC CONVENIENTLY AND IN COMFORT.

WHEREAS, it is a fact that Ormoc City is a focal point of entry and departure of computers due to its strategic location in Leyte province and with the existence of Philippine-Japan Highway;

WHEREAS, although the principal medium of travel from Ormoc to and vice versa is by sea, nevertheless, many of the daily commuters Ormoc City (to include commuters from far flung municipalities of prevince), are often stranded in Ormoc, for they could no longer be named ted but of the inadequate service of shipping companies;

In a way to attend to and meet itineraries of business time, a good number of commuters have confided their resolve be accommodated by air service, however, servicing by PAL for Grmoc-Cabi/Cebu-Ormoc route has been suspended probably as one measure by Management due to the developing crisis in the Middle East;

WHEREAS, this measure by Management has all out hampered or created a lot of disadvantages to the commuting public, hence request for reconsideration;
